

The interested candidates are also required to submit a Biodata/Curriculum Vitae on the said date. The upper age limit is 65 (Sixty Five) Years.



Terms and Conditions of Engagement on Contract Basis

- 1. Tenure:** The tenure of engagement on contract basis shall be for a period of Six months w.e.f from the date of his joining/ assuming duties in HPPCL. Provided further that HPPCL can terminate this engagement even before the expiry of the above period by giving notice of one month in advance or paying one month's remuneration in lieu of notice of one month in case the conduct and performance of the engaged Personal is not found satisfactory or the services are not required any more.
- 2. Fixation of Pay:** On engagement on contract basis he/she shall draw fixed emoluments on the basis of last pay drawn at the time of superannuation minus pension on monthly basis.
- 3. Place of Posting/Head Quarter:** Corporate Office, HPPCL, Himfed Building , BCS, New Shimla-09
- 4. TA/DA:** He/she shall be entitled to TA/DA as admissible/entitled in the Corporation against the Kanungo/Patwari in HPPCL.
- 5. Leave:** He/She will only be entitled to one casual leave for each completed month.
- 6. Residential Accommodation:** He/She will be entitled to the allotment of bachelor accommodation, if available or otherwise he/she will be entitled to receive House Rent Allowance as per State Government/ HPPCL Rules.
- 7. Other Facilities:** He/She shall be entitled to all perks and facilitates equivalent to the Level of Supervisory/Workmen cadre in HPPCL.
- 8.** He/She will perform routine works and will reside at a place where he is posted from time to time.
- 9.** Consistent and unauthorized absence from work without permission of a competent authority will result into cancellation of his/her engagement.
